

ASLI MEMBERSHIP POLICY

This policy details the terms and conditions for ASLI Membership on behalf of the Board of the Association of Sign Language Interpreters (ASLI):

1. ELIGIBILITY

There shall be three categories of ASLI Membership. Members are required to join at, and upgrade to, the highest membership category for which they are, or become eligible, for. Applications will be considered from those whose courses/qualifications do not appear on these lists if they no longer exist.

1.1 WHO MAY JOIN ASLI AS A FULL MEMBER (MASLI)?

Any Individual Registered with the NRCPD as RSLI or RSLT or as an interpreter for deafblind people

Any individual who holds one of the following qualifications, which meet the National Interpreting Standards for BSL/English Interpreters and Translators:

UCLAN/SLI Post Graduate Diploma in BSL/English Interpreting and translation

Heriot Watt University MA (Hons) in British Sign Language (Interpreting, Translating and Applied Language Studies)

University of Leeds MA in Interpreting Studies: BSL-English

SLI Advanced Diploma in Interpreting and Translation: BSL-English

IBSL Level 6 Diploma in BSL/English Interpreting Studies

IBSL Level 6 Diploma in Sign Language Interpreting Studies

University of Leeds Post Graduate Diploma in Interpreting Studies: BSL-English

Wolverhampton University BA (Hons) in Interpreting (BSL/English) (graduates who achieve a first-class degree from September 2017 onwards*)

Level 4 NVQ in Interpreting (BSL/English) & Level 4 NVQ in BSL (pre 2010)

Level 6 NVQ in Interpreting (BSL/English) and Level 6 NVQ in BSL

Signature Level 6 Certificate in Working Effectively with Deafblind Manual and Visual Frame and Hands On Signers (Applicants to the NRCPD register will also require a recognised Level 6 qualification in BSL or other sign language as appropriate)

(1.1 CONTINUED) SIGN LANGUAGE TRANSLATORS

Durham University MA in Translation Studies (graduates who have successfully completed the professional pathway including MELA43930 addressed using static and scrolling English and BSL) (Registration will be accepted from graduates up to and including July 2014. This course is not currently being offered).

Signature Level 6 Diploma in Sign Language Translation

University of Wolverhampton MA Interpreting. (course available from 2018) Graduates of the MA Interpreting or those exiting with the Post Graduate Diploma interpreting Graduates exiting with a Post Graduate Certificate having studied: 7IG003 - Critical reflective interpreting practice and; 7IG004 – Interpreting – healthcare settings; and 7IG005 – Interpreting – Legal settings

Other, subject to approval by the Board

1.2 WHO MAY JOIN AS AN ASSOCIATE MEMBER?

Any individual regulated by the NRCPD as TSLI or TSLT

Any Individual on a course that on successful completion allows them to register as a RSLI, RSLT or an interpreter for deafblind people

Any individual who has successfully completed one of the following interpreter training courses. It is essential for all applicants to have passed the BSL and Interpreting modules/units to the required levels:

University of Wolverhampton BA Hons in Interpreting BSL/English

University of Bristol BSc Deaf Studies (Interpreting).

UCLAN BA (Hons) in Deaf Studies (must include all Graduate Diploma modules).

UCLAN/SLI Graduate Diploma in BSL & Communication Studies.

Heriot-Watt University Certificate in Interpreting Studies & Skills.

Middlesex University/City Lit BA (Hons) Deaf Studies Communication Support and Education (Interpreting Option).



University of Durham Postgraduate Diploma in Interpreting with the Deaf Community.

Belfast Metropolitan College Introduction to BSL/English Interpreting Certificate

N.B. Some students will be eligible to join as an Associate if able to be a TSLI with the NRCPD. Working interpreters should be Associate members as they will get the benefit of Professional Indemnity Insurance.

3. COST OF MEMBERSHIP

7. MEMBERSHIP FOR INTERNATIONAL APPLICANTS

It is the general policy of ASLI that interpreters who hold interpreting qualifications from other countries, but are living and working in the UK should be able to become members of ASLI.

Procedure for applicants with overseas qualifications applying for entry into the directory as an interpreter of a foreign signed and spoken language:

- 1. An enquiry for membership is made to the ASLI Office office@asli.org.uk
- 2. The office will contact the person and ask for copy of their Overseas Qualification. If this document is not in English, the applicant must also provide a translation into English. This information will be passed to the Board of Directors.
- 3. The Board will investigate the Overseas Interpreting Qualification and in consultation with external bodies such as the European Forum for Sign Language Interpreters (EFSLI) or the World Association of Sign Language Interpreters (WASLI) decide on eligibility.
- 4. The Board will decide whether the Overseas qualification enables Full, Associate or Supporter status within ASLI.
- 5. The applicant will be informed of the decision by the ASLI office.

Procedure for applicants with overseas qualifications applying for entry into the directory as an interpreter of a foreign signed and spoken English language.

As above, plus:

English Competence

As part of this investigation the English language abilities of overseas interpreters will be taken into consideration - especially when English is not one of the languages of the overseas qualification. Where the spoken language of the qualification is not English



applicants will be required to provide evidence of an English qualification equivalent to A Level standard or the necessary IELTS score (6) required for university entry.

Procedure for applicants with overseas qualifications applying for entry into the directory as an interpreter of BSL and English.

Applicants must meet the membership criteria for members who are qualified in Britain. i.e. have evidenced their ability to practice at the National Occupational Standard.
